School Description and Mission Statement – Most Recent Year

Mission Statement: The staff and administration of Canyon View School are dedicated to providing the highest quality academics to students with challenging behaviors. We believe that it is through education, socialization and communication that students will develop the skills necessary to succeed.

Educational Philosophy: It is only through the collaborative efforts of community members, parents, administrators, teachers and staff, that our students will reach their full academic potential.

Canyon View School is a Non-Public School (NPS) certified by the California Department of Education. The NPS serves students from Local Education Agencies (LEA) throughout the East San Gabriel Valley SELPA, West San Gabriel Valley SELPA, Pomona Unified School District SELPA, Puente Hills SELPA, and West End SELPA. Canyon View provides Specialized Academic Instruction and related services to students with Autism, Emotional Disturbance, Intellectual Disabilities (Mild/Moderate and Moderate/Severe), Multiple Disabilities, Other Health Impairments, and Specific Learning Disabilities. The NPS serves students between the ages of 05-22.

Canyon View provides related services as indicated in the student's IEP. These include: counseling and guidance, behavioral services, language and speech; Parent Counseling and Training and Psychological Services are also available for students with Educationally Related Mental Health Services. The NPS offers auxiliary services to meet students' needs including: research and media centers, library, Canyon View provides vocational training to include programs for higher functioning adolescents with developmental disabilities and a specially designed sports program including: swimming, basketball, baseball.

Canyon View provides a highly structured educational setting with a small student-staff ratio and a school-wide behavioral program. Programs are designed to address the disability, behavioral, and emotional needs of the students, in alignment with their Individual Educational Program. The curriculum is state approved and adopted through Bonita Unified School District; it includes both core academic course-work and functional skills instruction. Students follow the graduation requirements of their district of residence and diplomas are issued by the district after the completion of a transcript graduation check.

Canyon View School's goal is to prepare its graduates to be effective communicators, academic achievers, and productive citizens.

School Facility Conditions and Planned Improvements

The California Department of Education conducted an on-site review of Canyon View School on October 28-31 of 2014. The NPS was determined as compliant in all areas of the Health and Safety portion of the review. Canyon View has recently completed facility improvements to include drought-resistant landscaping.

Professional Development

Canyon View School is provided extensive opportunities for training and professional development through the McKinley Training Center, which is located on school grounds. In addition 2 weeks of school-specific trainings are offered prior to the beginning of each school year. Teachers and other staff are encouraged to attend courses and trainings outside of the agency and tuition reimbursement is a benefit for the staff. The school staff meets monthly for department-specific trainings.
